Introduction

Blackwood & Smith LLP is a limited liability partnership incorporated in Scotland with registered number SO0306497. Our registered office is at 39 High Street, Peebles EH45 8AN. Throughout this Privacy Notice all references to "we", "us", "our" or "Firm" refers to Blackwood & Smith LLP.

We are committed to protecting and respecting your privacy.

This policy sets out the basis on which any personal information we collect from you, or that you provide to us, will be processed by us.

Please read the following carefully to understand our views and practices regarding your personal information and how we treat it.

Information we may collect from you

We may collect and process the following information about you:

- Personal data provided by you or your representative directly, from other people you know, including family members and people you are financially linked to or from other organisations who have referred you to us.
- Details of your visits to our site including, but not limited to, traffic data, click tracking, location data, weblogs and other communication data, and the resources that you access.
- The correspondence you provide if you contact us.

- Where you are the client, it will sometimes be necessary for you to provide us with information directly, and in those circumstances it is your responsibility to ensure that all such information is complete in all material respects and not misleading. The accuracy and appropriateness of our advice may be affected as a consequence of your failure to do so. If any information changes, please let us know so that we can keep it updated on our systems.

IP addresses and cookies

We may collect information about your computer, including where available your IP address, operating system and browser type, for system and business administration and for usage monitoring. This is statistical data about our user's browsing actions and patterns and does not identify any individual.

Cookies are small text files placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site. Where we store your personal data

What do we do with your information

How long do we keep your information

What basis do we have for processing your information

Your rights
